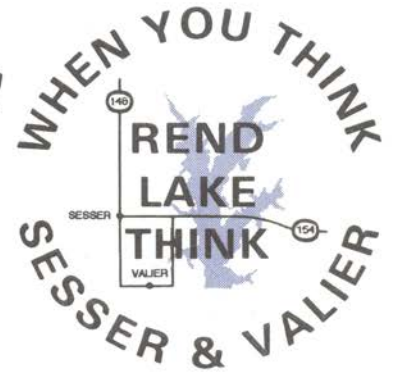

**Notice of Proposed Property Tax Increase for
Sesser-Valier Community Unit School District No. 196**

- I. A public hearing to approve a proposed property tax levy increase for Sesser-Valier Community Unit School District No. 196 for 2012 will be held on December 10, 2012, at 5:20 PM at Sesser-Valier High School, 4626 State Highway 154, Sesser, Illinois.

- II. The corporate and special purpose property taxes extended or abated for 2011 were \$1,032,800.47.

The proposed corporate and special purpose property taxes to be levied for 2012 are \$1,136,080.00. This represents a 10.00% increase over the previous year.

- III. The property taxes extended for debt service and public building commission leases for 2011 were \$129,308.07.

The estimated property taxes to be levied for debt service and public building commission leases for 2012 are \$129,300.00. This represents a 0.01% decrease over the previous year.

- IV. The total property taxes extended or abated for 2011 were \$1,162,108.54.

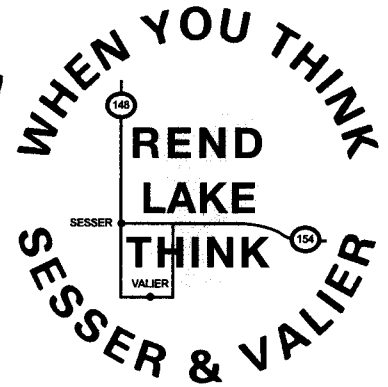
The estimated total property taxes to be levied for 2012 are \$1,265,380.00. This represents a 8.89% increase over the previous year.
