NEW BUSINESS

ADMINISTRATION OF OATH OF OFFICE FOR NEWLY-ELECTED SCHOOL BOARD MEMBER: Superintendent Henry administered the Oath of Office for the newly-elected school board member Kevin Acosta.

NOMINATION & ELECTION OF BOARD PRESIDENT: District Superintendent Jason D. Henry opened the floor for nominations for board president. Glenn Gulley nominated Teresa Stacey for board president. Kevin Acosta seconded the nomination. Roger Hicks nominated Carroll Kelly for board president. Brent Loucks seconded the nomination. Superintendent Henry called for nominations two additional times; none were forthcoming. A motion was made by Hicks and seconded by Acosta to close the nominations for board president.

Voting was as follows: All voted yea. There being six (6) yeas and zero (0) nays, Superintendent Henry declared that the motion carried.
