Superintendent Henry presented a thank-you note from the family of Jean Crocker for the board's expression of sympathy (donation to scholarship fund).

CUSTODIAL & MAINTENANCE SUPERVISOR: No report.

K-8 PRINCIPAL: Mrs. Logsdon, Elementary/JH Principal, presented information regarding the following to the board: Trust fund, upcoming activities, recent activities, recognition for student accomplishments, professional development activities, and a Student Engagement Highlight. Mrs. Logsdon presented the Sesser-Valier Elementary/Junior High Student-Parent Handbook proposed revisions for 2016-2017. The most recent copies of the S-V Happenings were presented to the board members.

H.S. PRINCIPAL: Mrs. Page, High School Principal, presented information regarding the following to the board: Trust fund, upcoming activities, a Student Engagement Highlight, and recognitions for student accomplishments. Mrs. Page presented information to the board regarding information on the impact on S-V students when they are not offered a foreign language class. She then presented the Sesser-Valier High School Student-Parent Handbook proposed revisions for 2016-2017 and she explained that there were no proposed revisions for the 2016-2017 Extracurricular Rules/Random Student Drug Testing Procedures.

Superintendent Henry presented information to the board members regarding Senate Bill 100 (dramatic change in discipline procedures, i.e.: suspensions, expulsions). He indicated that these changes would be effective July 1, 2016, therefore; any changes that will need to be made to the handbooks (resulting from mandated board policy changes) will be added as an amendment.
