#### **NEW BUSINESS**

ADMINISTRATION OF OATH OF OFFICE FOR NEWLY-ELECTED SCHOOL BOARD MEMBERS: Superintendent Henry administered the Oath of Office for the newly-elected school board members: Roger Hicks, Samantha Ketteman, Brent Loucks, and Kathy Schoenbaechler.

NOMINATION & ELECTION OF BOARD PRESIDENT: District Superintendent Jason D. Henry opened the floor for nominations for board president. Teresa Stacey nominated Carroll Kelly for board president. Superintendent Henry called for nominations two additional times; none were forthcoming.

Superintendent Henry asked for board members in favor of electing Carroll Kelly for board president to signify by raising their right hands.

All members present voted for Carroll Kelly Superintendent Henry declared that Carroll Kelly was elected as board president.
