**Notice of Proposed Property Tax Increase for  
Sesser-Valier Community Unit School District No. 196**

- I. A public hearing to approve a proposed property tax levy increase for Sesser-Valier Community Unit School District No. 196 for 2017 will be held on December 11, 2017, at 5:50 PM at Sesser-Valier High School, 4626 State Highway 154, Sesser, Illinois.

- II. The corporate and special purpose property taxes extended or abated for 2016 were \$1,207,785.70.

The proposed corporate and special purpose property taxes to be levied for 2017 are \$1,328,560.00. This represents a 10.00% increase over the previous year.

- III. The property taxes extended for debt service and public building commission leases for 2016 were \$140,647.81.

The estimated property taxes to be levied for debt service and public building commission leases for 2017 are \$133,597.11. This represents a 5.01% decrease over the previous year.

- IV. The total property taxes extended or abated for 2016 were \$1,348,433.51.

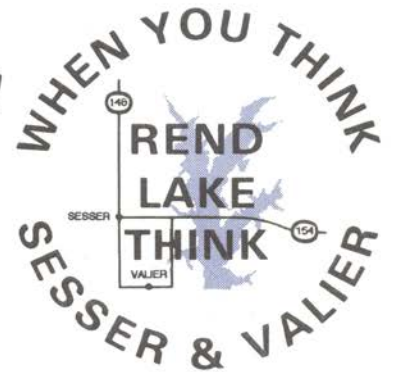
The estimated total property taxes to be levied for 2017 are \$1,462,157.11. This represents an 8.43% increase over the previous year.
