### **NEW BUSINESS**

ADMINISTRATION OF OATH OF OFFICE FOR NEWLY-ELECTED SCHOOL BOARD MEMBERS: Superintendent Henry administered the Oath of Office for the newly-elected school board member(s): Megan Rounds (all members re-affirmed the oath).

NOMINATION & ELECTION OF BOARD PRESIDENT: District Superintendent Jason D. Henry opened the floor for nominations for board president. Kevin Acosta nominated Teresa Stacey for board president. Roger Hicks seconded the nomination. Superintendent Henry called for nominations two additional times; none were forthcoming.

A motion was made by Acosta and seconded by Schoenbaechler to close the nominations for board president.

Voting was as follows: All voted yea. Superintendent Henry declared nominations closed.

Superintendent Henry asked for board members in favor of electing Teresa Stacey for board president to signify by raising their right hands.

All members present voted for Teresa Stacey. Superintendent Henry declared that Teresa Stacey was elected as board president.

NOMINATION & ELECTION OF BOARD VICE-PRESIDENT: President Stacey opened the floor for nominations for board vice-president. Acosta nominated Kathy Schoenbaechler for board vice-president. APPOINTMENT OF BOARD REPRESENTATIVE FOR FRANKLIN-JEFFERSON SPECIAL EDUCATION DISTRICT NO 801 GOVERNING BOARD (STACEY, TERESA): A motion was made by Loucks and seconded by Hicks to appoint, by resolution, Teresa Stacey as board representative for the Franklin-Jefferson Special Education District No. 801 Governing Board.

Roll call voting was as follows:
